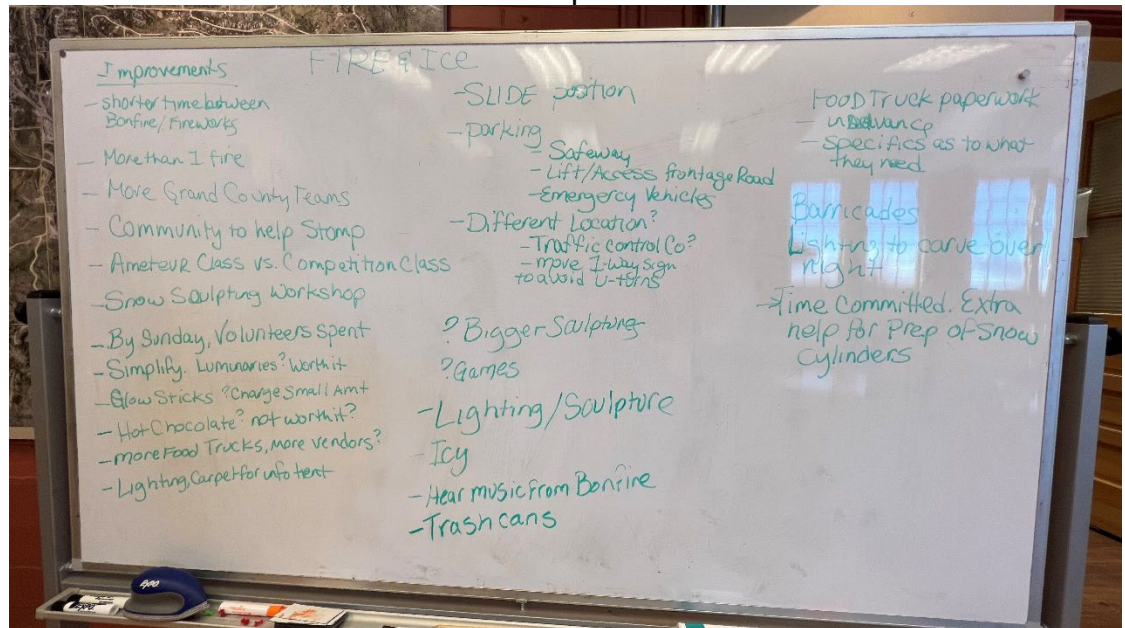
Callie moved, and Tara seconded the **motion** to approve the Agenda. **Motion carried: 7-0.**
