Three-Dimensional Wall Sign, Approx. 24" x 144":

3 - The sign would be constructed from 1 1/2" thick wood alternative, laminated to an aluminum composite. It would have a recessed or projecting, and/or a hand textured background to look similar to carved wood. It would be painted with acrylic polyurethane and have an automotive clear coat for maximum durability. The graphics would be individually cut out, prismatically carved where possible, applied in separate layers to give the sign a true 3-D look. The sign would have a hidden/ welded aluminum mounting frame that attaches it to the building. Removal of the existing sign is included along with the installation of the new sign.
