

Fraser Business Enhancement Grant Application

Fraser Business Enhancement Grants are intended to support current businesses and improve the economic vitality of Fraser by encouraging enhancements to the physical appearance of business properties, improvement of public infrastructure, amenities and gathering places, and increased ADA accessibility. Grant requests of up to \$25,000 per business space will be considered. 50% project match is generally required; lower project matches may be considered for projects providing a maximum public benefit. For priority consideration, applications must be submitted by February 1, 2026. If funding for projects remain after consideration of initial applications that meet the deadline, rolling application will be considered until grant program funding for the year is exhausted. Colorado Corndog Company Trailer Service Window & Serve Tray Replacement (Safety + Exterior Improvement)

Description of Project

Colorado Corndog & Burger Company is requesting Business Enhancement Grant funding to replace the failing front service window assembly and the deteriorating exterior serve tray on our food trailer located in a permanent operating site in Fraser. The current service window will no longer remain safely open and has become a safety hazard for staff and customers. This project will replace the full front window unit, including two smaller sliding/up-down windows and a larger center window, along with replacing the front serve tray to restore a safe, functional, and polished customer-facing service area.

Describe the benefits this project will provide to your business, the public, and the Town of Fraser?

This project provides immediate safety improvements by eliminating a hazardous service window that can slip or fall during use. Replacing the window assembly and serve tray will improve the customer experience by creating a safer, more efficient ordering and pickup point and reducing service bottlenecks. The improvements also enhance the exterior appearance of a highly visible local business operating within Fraser, contributing to a cleaner, more welcoming streetscape and strengthening Fraser's identity as a vibrant, visitor-friendly mountain community.
